GENERAL

1. The following will be for the parent's/guardian's account:

- The e-learning device and any insurance, maintenance or other costs relating to the device
- All textbooks, workbooks, learning materials (including the cost of e-books) and stationery requirements – please contact the school for more information and related costs
- School uniforms and Curro sports gear
- Entrance fees, travel costs, accommodation and food for additional **non-compulsory school** excursions and sports/culture trips and camps, unless otherwise advised by the school
- School photos
- Therapists' and psychologists' fees

2. Aftercare fees

Aftercare fees are charged over **12 months** and are therefore payable during school holidays. The notice period for aftercare cancellation is one month.

Aftercare fees for 2027 include the following:

- One meal and a snack per day; meal is served during 2nd break
- Supervision until 17:30
- Limited homework support
- Reading of homework

Aftercare fees for 2027 exclude the following:

- Specialised subject and homework support
- Preparation of speeches and poems

3. Bus fees

- Bus fees are charged over **12 months** and are therefore payable during school holidays.
- The notice period for bus cancellation is one month.
- Availability is limited and dependent on the assigned routes on offer.
- Bus fees are subject to change.

4. E-learning devices

E-learning devices will be utilised by all learners from **Grade 5 to Grade 7**.

This will have the following impact on you:

- If your child is in **Grade 5 to Grade 7**, you will be responsible for purchasing an e-learning device for your child to use. The school will provide you with details and the minimum specifications required for the device.
- You will be responsible for the insurance and general maintenance and care of the device.

5. Termination of enrolment

Parents/Guardians may terminate the admission and enrolment of a learner after the commencement of the first day of the school year by providing the school with at **least 3 (three) calendar months'** written notice of termination.
