1. School fees

- Security access tag for entry to Helderwyk Estate

2. E-learning devices

E-learning devices to be utilised by all learners from Grade 8 to Grade 12.

This will have the following impact on you:

- If your child is in Grade 8 to Grade 12, you will be responsible for purchasing an e-learning device for your child to use. The school will provide you with details and the minimum specifications required for the device.
- Please note: No phones are to be used as e-learning devices due to inadequate screen size.
- You will be responsible for the insurance, general maintenance and care of the device.

3. Termination of enrolment

Parents/Guardians may terminate the admission and enrolment of a learner after the commencement of the first day of the school year by providing the school with at **least 3 (three) calendar months'** written notice of termination.

4. Curro Choice: Wider subject choice offering

Learners have access to a wider subject choice (beyond what we offer at school). These may be taken instead of any elective subject, or as an 8th, 9th or 10th subject. Additional costs as outlined below are applicable only when taken as an 8th, 9th or 10th subject.
